| Discussion Items | <ul style="list-style-type: none"> Homeland Security Grant Review <ul style="list-style-type: none"> Dana McNeil (BZPD) presented their desire to acquire a Throw Phone, NVG and Robot for critical access. Brian Nickolay (Hyalite FD) presented their desire to acquire ballistic PPE for the Rescue Task Force. Hyalite is requesting 42 helmets, vests, and plates with 34 kits going to Hyalite and 8 RTFPPE kits going to Central Valley FD. Jeremy Kopp (GCS) presented their proposal to acquire a multi-use robot with night vision for SRT use. John Alston & Jeremy Kopp expressed support for the security enhancements for the City of Three Forks water supply facilities, but no formal proposal was made by the City of Three Forks. |
| Updates | <ul style="list-style-type: none"> Patrick Lonergan provided an update on the ongoing Emergency Medical Services Study. A final report is expected in May. Jay Pape provided an update on the Wildfire Mitigation Program. Outreach has begun for the Bridger Canyon- Fire Adapted Gallatin project. He is still waiting for an award status update on the pending FEMA & CWDG grants. Jay also provided a progress overview on the MCI Plan updates with revisions nearly completed. Additionally, the Gallatin County Emergency Plan has been adopted by all entities and is awaiting final adoption by Gallatin County prior to publishing. |
