Minutes Approval	• June 15, 2023- Approved
Presentations	 NWS provided an overview of the short/long range forecast. Northern County is not in drought. Southern portion abnormally dry. July typically dry w/pockets of heavier storms. Water-year precipitation is "normal." July was hot but not unusual temps. No significant changes in drought conditions currently. Cooling to warming trend though 3rd week of August. Precipitation outlook is for unsettled wet pattern may persist into weeks 3-4 of September. Sept thru Oct trend is dryer, no significant drought developing. Dec-Feb temps are currently trending warmer with equal chances of above/below normal precipitation. David Stamey of Stillwater County gave a recap of the MRL Train Derailment. Local flooding on June 23 caused a bridge failure resulting in derailment with a train in the Yellowstone river at 06:15 in the 2nd most populated portion of Stillwater County. EPA representative was on site by afternoon with an IMT in place by second day and unified command established utilizing Stillwater County, DEQ, EPA and MRL. A command trailer was in place with FirstNet providing a portable cell tower and good connectivity. Heavy
	equipment arrived on site during day 1 of incident. Challenges included media inundation, managing presence of dignitaries, fiber optic line was cut during derailment impacting the second-most populated portion of the county
Discussion Items	 Gallatin County Floodplain Management Report on Reducing Impacts from Flooding- Sean O'Callaghan present their progress on the five objectives. #1) Mitigation project on the Jefferson River at Three Forks includes replacing multiple bridges. #2) Draft flood studies for the mapping of hazards on the Madison & Jefferson Rivers. Consultant hired to evaluate stormwater permitting authority for Gallatin Co. #3) Working toward the replacement of multiple bridges with history of flood impacts. #4) Conducted annual outreach about insurance and training for realtors and builders.
