Presentations	• John Rasmann from MT DEQ gave presentation outline their response procedures and reporting requirements for releases and spills. John & Shasta Steinweden are the On-Scene Coordinators. Reporting requirements include: Releases or Spills of hazardous substances that meet or exceed reportable quantities; Spills, overfills, suspected releases from underground tanks and petroleum storage tanks; Releases or spills of any materials that would lower groundwater quality below quality standards. This includes spill that enter or may enter state water or drainage that leads to surface water; Spills than cause a sludge or emulsion beneath the surface of the water, stream banks, or shorelines. The minimum amount of information needed for a report includes: Name/contact info of responsible party, DOT # if known, Date, Location (lat/long or MM), Water impacts if any. MT DEQ has Duty Officer coverage 24hr/7d/365yr. NOTE- DEQ does not have a response funding source.
